- The sale of the club will affect our community in several ways including but not limited to:
 - development likely to encroach on our property lines increasing noise pollution, clearing trees and degrading our beautiful views
 - o increased traffic (current city planning/infrastructure not sufficient as is)
 - reduced property value
 - o members will receive some share of the sale depending on their agreement
- Our development was the result of sale of some of the pool property, so there is a precedence for the sale.
- Action Items:
